Abstract Content

Please enter the abstract text (max 350 words not including table or figure). Maximum 1 table OR 1 figure allowed.

Please structure your abstract as follows:

Previous presentation/publication

Work which has been previously presented may be submitted for presentation at the conference provided it has not been published as a full manuscript. If your abstract will be presented or published in any form prior to the conference we will ask you to give details of this during the online submission process.

Permission to publish

We will ask you to confirm that you give us permission to publish your submission on electronic media and in hardcopy if it is accepted for presentation.

Author approval & disclosures

We will ask you to confirm that this submission has been approved by all authors. We will ask you if any of the authors have any commercial interests or associations that could be perceived as posing a conflict of interest regarding this submission? If yes, you will be asked to give details during the submission process.

Author will attend ICCBH 2024

At least one author will register in full to attend and present the abstract (either as an oral presentation or poster) at the Conference.

The subject categories are as follows

New Investigator Award Application: Confirmation of Eligibility

If you wish to be considered for a New Investigator Award, you will need to submit a confirmation of eligibility form which you can download from the conference website on the Awards and Grants page <u>HERE</u>.

In order to be considered for an award you:

- 1. Must be first and presenting author.
- 2. Must be in training or within 5 years of attaining PhD or MD or equivalent

Abstract submission - Terms and conditions

Abstracts should not be submitted to this conference if are not able to confirm that you agree with the specific terms and conditions outlined in the guidelines detailed below:

- The abstract submitted adheres to the abstract submission guidelines.
- The abstract has only been submitted once for ICCBH 2024.
- This work has not been previously published as a full manuscript.
- Submission of an abstract that deals with experimentation on humans or animals implies that the authors adhere to any applicable guidelines dealing with human or animal experimentation and that the appropriate approval has been granted from the institution's review committees.
- This submission has been approved by all authors.
- Copyright permission is given to allow publication of the abstract, poster and/or any additional documents as required.
- It is the sole responsibility of the Presenting Author to communicate with co-authors.
- The submission of an abstract constitutes a formal commitment by the Presenting Author to present the work (if accepted) in the form, session and time assigned by the Programme Committee.
